DHS COVIDSafe Plan

This COVIDSafe Plan (and any subsequent version of it) is subject to change at any time and without prior notification, at the discretion of the Board in consultation with the Communal Rabbi. This might include (but not limited to) changes based on government regulations, recommended guidelines of health authorities, halachic developments and how our community adheres to this Plan.

1. COVIDSafe Wardens	<ul style="list-style-type: none">• The board members of DHS and staff of DHS present at each DHS service ("COVIDSafe Warden(s)") will maintain compliance with this COVIDSafe Plan for DHS service.• This includes:<ul style="list-style-type: none">- Together with External Security and CSG, ensuring only those on the Register of Attendees enters the Shule's premises for their allocated service- Seat arrangements, entry and exit from the building, and social distancing requirements are maintained, as required• At all times it is a condition of access that attendees must comply with all instructions from the COVIDSafe Warden(s).• Failure by an attendee to comply with any instructions of the COVIDSafe Warden(s), CSG or External Security personnel or to comply with DHS' CovidPlan and policies may result in an attendee being denied entry to the Shule or being asked to leave the Shule's premises.
2. Criteria for Attendances at Services	<ul style="list-style-type: none">• Complying at all times with the 2 square metre rule• Masks are compulsory for ages 12 and above.• Proof of double vaccination status for anyone aged 14 years and older.• Unvaccinated attendees must provide confirmation of a negative PCR or RAT test to [admin@dhs.org.au] at least 24 hours before attending Shabbat or Yom Tov services.• Unvaccinated attendees attending regularly daily minyanim must provide confirmation of a negative PCR or RAT test to [admin@dhs.org.au] each Monday and Thursday of every week.• Unvaccinated children under 12 years of age are able to attend with a vaccinated adult• Attendees who leave the Shule are not to leave their children at the Shule under any circumstances.
1. Registration Form and Selection	<p>FOR SHABBAT AND YOM TOV SERVICES - Only those who are on the Register of Attendees for that service will be able to enter the Shule's premises.</p> <p>FOR REGULAR WEEKDAY SERVICES ONLY – register on the day of the service using the electronic COVID Safe Check-in registration tool displayed at the entrance to the Shule or manual check in system if you do not have a smart phone.</p>
2. On Arrival Procedures	<p>FOR SHABBAT AND YOM TOV SERVICES - Anyone who is not on the Register of Attendees will not be allowed to enter or remain on the Shule's premises, unless otherwise determined by a CovidSafe Warden, in compliance with section 2.</p>
